Hazardous ingredients: MICROBIOCIDES IN AQUEOUS MEDIA MBO <1%
[Xi] R36/37/38; [Sens.] R43; [N] R50

Contains: Contains a plasticised acrylic polymer, fire retardant fillers, blowing agents and minor additives including white spirits

4. FIRST AID MEASURES (SYMPTOMS)
